EXPLANATION OF TERMS USED

BID TYPE:

RS 6 Bonus Bidding system with a fixed royalty rate of 16 2/3%; possible royalty suspension for 20 bcf deep gas production. (0-199 meters water depth)

ROY - Bonus Bidding with a fixed royalty rate of 16 2/3%; no automatic royalty suspension (200-399 meters water depth)

RS5 - Bonus Bidding with a fixed royalty rate of 12 1/2%; possible royalty suspension for 5 mmboe (400-799 meters water depth)

RS3 - Bonus Bidding with a fixed royalty rate of 12 1/2%; possible royalty suspension for 9 mmboe (800-1599 meters water depth)

RS4 - Bonus Bidding with a fixed royalty rate of 12 1/2%; possible royalty suspension for 12 mmboe (1600m and greater water depth)

RNK - Rank is the order of bid when more than one bid is submitted for a tract. The high bid is listed first; successive bids are listed in descending monetary order.

I - Invalid bid on this lease number which under Phase 1 bid evaluation criteria was deemed unacceptable in accordance with MMS regulations.

R - Denotes rejected bid.
